

**DECREE**  
**of the Chancellor of the Cracow University of Economics**  
**number R-0201-28/2016**  
**from July 4, 2016**

**about**  
**payments for student dorms in the academic year 2016/2017**

Based on the art. 66 of the act Higher Education Law (Dz. U. z 2012 r., poz. 572, z późn. zm.), § 31 of the Cracow University of Economics' Statute, it is decreed:

§ 1

**Applied to the period of October 1, 2016 – September 30, 2017:**

1. A monthly payment is determined:
  - 1) Spot in the student dorm "Fafik":  
for the Cracow University of Economics student – 390 PLN (in A-type rooms)  
370 PLN (in B-type rooms)
  - 2) Spot in the student dorm "Merkury"  
for the Cracow University of Economics student – 370 PLN  
for students of other Universities – 390 PLN  
for other people – 400 PLN
  - 3) Rooms in a higher standard rooms in student dorm "Fafik":  
Single room with bathroom and kitchenette S-II – 1000 PLN  
Single room in composition S-IV – 700 PLN  
Spot in a double room with a bathroom S-1 – 450 PLN  
Spot in a double room in composition S-IV – 550 PLN  
Spot in a double room in composition S-V- 650 PLN  
Spot in a "01" type room in student dorm "Merkury" extra – 30 PLN  
Spot in a "06" type room in student dorm "Merkury" – 350 PLN  
Spot in a double higher standard room in student dorm "Merkury" – 500 PLN
  - 4) A one-time security deposit to cover potential damages and indebtedness is returned after moving out and amounts to a monthly fee for a spot.
2. Student is obliged to report to the administration of the student dorm a will to resign from the spot at least 7 days before a planned moving out.
3. In a case of not fulfilling the obligation from section 2, student will be charged with a payment calculated for the accommodation time – as a product of 1/30 of the monthly fee and number of days when student was using a spot in the student dorm.
4. A 24 hour fee is determined:
  - 1) Guest room – 110 PLN
  - 2) S-1 room in student dorm "Fafik" – 80 PLN
  - 3) Spot in compositions S-IV and S-V in student dorm "Fafik" – 50 PLN
  - 4) Overnight stays in student rooms:  
(applying to a stay shorter than 14 days):
    - a) students – 25 PLN
    - b) other – 30 PLN

5. In student dorm "Fafik", for people who are not Cracow University of Economics students, a VAT tax in the bidding amount is added to the monthly fee, other prices include VAT tax.

The decree comes into force with the day of signing.
